**STATUTORY DECLARATION**

### **Agreements**

10. I agree that if I am granted an additional allowance for the support of the children;
- (a) I will forthwith advise LIA of any change in the residence, dependency, legal guardianship or legal responsibility for support or maintenance of the children;
  - (b) I will provide such further evidence as to the residence, dependency, guardianship, or legal or actual responsibility for support or maintenance of the children as LIA may reasonably require; and
  - (c) I will provide LIA with proof, in the form of receipts or cancelled cheques, that I am fulfilling my responsibilities as set out in paragraph 7 and I agree and understand that if I do not provide the necessary proof or do not contribute the additional allowance to the support or maintenance of the children, LIA may discontinue paying the additional allowance for the support of my dependent children to me, or, in its sole discretion, pay the additional allowance directly to the person referred to in paragraph 5 (b) or (c).

11. I agree that if I am granted an additional allowance for the support of my dependent spouse:
- (a) I will forthwith advise LIA of any change in my marital status;
  - (b) I will forthwith advise LIA in the event that my spouse is no longer dependent on me; and
  - (c) I will provide such further evidence as to my marital status and my spouse's dependency on me as LIA may reasonably require.

**Definitions**

12. In this my Statutory Declaration;
- (a) Dependent means a person who is dependent upon me as defined by Revenue Canada's Income Tax Regulations and who does not receive income in excess of the level of income allowed for a dependent spouse by Revenue Canada's Income Tax Regulations.
  - (b) Dependent Spouse means the person who is married to me or the person who has lived with me as my spouse for a period of at least six months prior to my application for assistance. This person is dependent upon me and does not receive income in excess of the level of income allowed for a dependent spouse by Revenue Canada's Income Tax Regulations.
  - (c) Words in the plural include the singular and words in the singular include the plural with the intent that all necessary changes in number will be made throughout.

And I make this solemn declaration conscientiously believing it to be true, and knowing that it is of the same force and effect as if made under oath, and by virtue of **The Canada Evidence Act.**
