These regulations may be cited as the *Inuit Community Government Election Forms Regulations*.

These regulations are made under subsection 3(2) of the *Inuit Community Government Elections Act*.

Terms used in these regulations and in the forms set out in Schedule A have the meanings assigned to them in the *Inuit Community Government Elections Act*.
