***The Nunatsiavut Electoral Officer is pleased to enact the following regulations:***

*Short Title*

**1.**

***These regulations may be cited as the Nunatsiavut Election Forms Amendment Regulations.***

*Authority*

***These regulations are made under subsection 5(10) of the Nunatsiavut Elections Act.***

*Interpretation*

***Terms used in these regulations and in the prescribed forms have the meanings assigned to them in the Nunatsiavut Elections Act.***

*Section 5 Added*

4.

*A new section is added to the Nunatsiavut Election Forms Regulations immediately following section 4 as follows:*

**Forms in Schedule A may be used in Presidential Elections and Plebiscites**

5.

The Nunatsiavut Electoral Officer may, in his or her discretion, direct that forms set out in Schedule A shall be used at an election for President making all changes in points of detail as the Nunatsiavut Electoral Officer considers necessary or appropriate.

*Section 6 Added*

5.

*A new section 6 is added to the Nunatsiavut Election Forms Regulations as follows:*

**Correction of Errors in Forms**

6.

The Nunatsiavut Electoral Officer or an election official may, when using or printing a prescribed form set out in Schedule A, B or C, correct minor and typographical errors without first requiring a formal amendment to these regulations or the form.

*The heading and first paragraph of Schedule A to the Nunatsiavut Election Forms Regulations are deleted and replaced with the following:*

***The heading and opening paragraphs of Schedule B to the Nunatsiavut Election Forms Regulations are deleted and replaced with the following:***

**ADDITIONAL FORMS TO BE USED AT AN ELECTION FOR PRESIDENT**

*Except where an additional form is prescribed for use at a Presidential Election in this Schedule, the forms prescribed in Schedule A for use in an election may be used at an election for President making any necessary changes in points of detail.*

**The following additional forms are prescribed for use in a Presidential election:**

*Form P-1 Amended*

10.

***Form P-1 of the Nunatsiavut Election Forms Regulations is Amended by deleting the words “of the Nunatsiavut Assembly for the above-mentioned constituency” and replacing them with the words “of Nunatsiavut” and by deleting the words “A public Notice fixing a day and a place of nominations of candidates(s) and a Public Notice of grant of Poll will be made and distributed in accordance with the Nunatsiavut Elections Act.”***

*Form P-2 Amended*

**11.**

***Form P-2 of the Nunatsiavut Election Forms Regulations is amended by deleting the words “of the Nunatsiavut Assembly” and replacing them with the words “of Nunatsiavut” and by deleting the words “Returning Officer” below the signature line at the end and replacing them with the words “Nunatsiavut Electoral Officer”.***

*Form P-3 Amended*

**12.**

***Form P-3 of the Nunatsiavut Election Forms Regulations is Amended by deleting the words “To Returning Officer” and replacing them with the words “To Nunatsiavut Electoral Officer” and by deleting the words “of the Nunatsiavut Assembly” and replacing them with the words “of Nunatsiavut”.***

*Form P-4 Amended*

**13.**

***Form P-4 of the Nunatsiavut Election Forms Regulations is amended by deleting the word “TO” in the Heading and replacing it with “BY”, deleting the words “of the Nunatsiavut Assembly” and replacing them with the words “of Nunatsiavut”, and deleting the words “Returning Officer” below the signature line at the end and replacing them with the words “Nunatsiavut Electoral Officer”.***

*Form P-5 Amended*

**14.**

***Form P-5 of the Nunatsiavut Election Forms Regulations is amended by deleting the words “Constituency of”, deleting the words “Returning Officer” in both places where they appear and replacing them in each instance with the words “Nunatsiavut Electoral Officer”, deleting the words “of the Nunatsiavut Assembly” and replacing them with the words “of Nunatsiavut”, and by deleting the words “held in this constituency” and the words “by electors in the above noted constituency”.***

*Form P-6 Amended*

*Form P-6 of the Nunatsiavut Election Forms Regulations is amended by deleting the words “Returning Officer” below the signature line at the end and replacing them with the words “Nunatsiavut Electoral Officer”.*

*Forms NP-2, NP-3 and NP-4 Amended*

16.

*Forms NP-2, NP-3 and NP-4 of the Nunatsiavut Election Forms Regulations are amended by adding the words “Nunatsiavut Electoral Officer” beneath the signature line for officials who may take the oath or affirmation of the person making the Affidavit, Form NP-3 is further amended by deleting “CANADIATE’S” in the heading and replacing it with “CANDIDATE’S” and Form NP-4 is further amended by deleting the word “SINGATURE” in the heading and replacing it with “SIGNATURE”.*

*Form NP-5 Added*

*The following Form, numbered NP-5, is added to the Nunatsiavut Election Forms Regulations immediately following Form NP-4 and the list of forms prescribed under Schedule A is amended accordingly:*
