COVID-19 Food Supplement Program (Canada)

On December 2, 2020, the Nunatsiavut Government announced details of a second round of support initiatives aimed at assisting Beneficiaries of the Labrador Inuit Land Claims deal with impacts associated with the coronavirus COVID-19 pandemic.

The purpose of the *COVID-19 Food Supplement Program* for the Constituency of Canada is to ensure seniors, low-income families and individuals have access to nutritional food (and equipment necessary to prepare food). Adequate nutrition is crucial for maintaining good health and having the ability to fight off infection.

Under this program, the Nunatsiavut Government will provide electronic gift cards or purchase orders on a biweekly basis for seniors (65 years of age and older) and eligible family units. Anyone whose application has been approved by December 9 will receive their first gift card within a few days. Gift cards can only be redeemed at stores chosen by eligible program recipients and where gift card purchase is available.

Eligible purchases include all food items (including yoghurt tubes and ice cream), with the exception of pop, energy drinks, chips, bars, candy, etc. Dishes, cutlery, food storage (containers) and laundry detergent are also permitted to be purchased.

Ineligible purchases include lottery tickets, tobacco products and alcohol.

Please note that gift cards or purchase orders not picked up within two weeks of being issued will be cancelled.

Eligibility

This program is only available to Beneficiaries of the Labrador Inuit Land Claims Agreement. Applications must be completed in order to be eligible to receive assistance under this program.

The tables below sets out the income cut off. Please note there are three (3) tables for the Constituency of Canada.
