

## Questions for the Request for Proposals Development of the Refreshed Nunatsiavut Tourism Strategy

1. Has a budget for this project been identified?

As this is an open and competitive process, no budget figures will be released by NG.

2. Given the various COVID-19 restrictions, how do you anticipate the required consultation being carried out within the indicated timeframe?

3. To help bidders understand the scope of the assignment, can you please indicate what you anticipate in terms of total budget for the assignment?

As this is an open and competitive process, no budget figures will be released by NG. Proponents should develop their proposal, as they feel appropriate.

4. Can you provide a list of local Inuit consultants who might be interested in working as part of a consulting team?

This is an open and competitive process and is open to anyone who wishes to submit a proposal. As this is an open and competitive process no budget figures will be released by NG. NG procurement is governed by Nunatsiavut's *Procurement Act* and evaluation of proposals on the basis of value for money is a primary consideration under that legislation.
