

COVID-19 Nunatsiavut Food Supplement Program

On December 2, 2020, the Nunatsiavut Government announced details of a second round of support initiatives aimed at assisting Beneficiaries of the Labrador Inuit Land Claims Agreement, residing in the Labrador Inuit Settlement Area, deal with impacts associated with the coronavirus COVID-19 pandemic.

The purpose of the *COVID-19 Nunatsiavut Food Supplement Program* is to ensure seniors, low-income families and individuals have access to nutritional food (and equipment necessary to prepare food). Adequate nutrition is crucial for maintaining good health and having the ability to fight off infection.

Under this program, the Nunatsiavut Government will provide purchase orders on a bi-weekly basis for seniors (65 years of age and older) and eligible family units. Anyone whose application has been approved by December 9 will receive their voucher on December 11. These purchase orders will be issued directly to stores chosen by eligible program recipients within each Labrador Inuit community.

Eligible purchases include all food items (including yoghurt tubes and ice cream), with the exception of pop, energy drinks, chips, bars, candy, etc. Dishes, cutlery, food storage (containers) and laundry detergent are also permitted to be purchased.

Ineligible purchases include lottery tickets, tobacco products and alcohol.

Please note that all purchase orders will expire two weeks after the date they are issued.

Eligibility

This program is only available to Beneficiaries of the Labrador Inuit Land Claims Agreement. Applications must be completed in order to be eligible to receive assistance under this program.

The table below sets out the income cut off levels.
