# EXPRESSION OF INTEREST JANITORAL SERVICES - POSTVIILE

The Nunatsiavut Government is currently seeking janitorial services to be provided for three (3) hours a day from Monday-Friday for the Nunatsiavut Government properties in the Community of Postville (the "Janitorial Services"). The anticipated start date for these services are November 22, 2021 or a date mutually agreed upon. The Nunatsiavut Government is requesting expressions of interest from individuals or businesses interested in providing the following Janitorial Services:

## **Janitorial Services**

# 1. Two (2) Office Buildings

## **Daily Cleaning:**

- Collection of garbage from entire building (including individual offices), emptying and replacing trash bags
- Sweeping and mopping all areas of the building
- Clean and disinfect floors, tables, chairs, countertops, fixtures, sinks and all other hard surfaces
- Maintaining the janitorial supplies inventory list and request cleaning supplies as needed
- Maintain the cleanliness of the bathroom including cleaning all urinals, toilets, sink and mirrors
- Disinfection all high touch areas including but not limited to counter tops, light switches, door knobs and handles
- Cleaning of dirty dishes left in the kitchen sink
- Vacuuming floor mats

## **Weekly Cleaning:**

- Clean inside windows and window ledges
- Disposing cigarette butts from cigarette can dispenser
- Ensure all shredded paper is removed from the paper shredder
- Vacuuming of any floor mats or any upholstered furniture
- Restocking of toiletries (toilet paper, paper towel and soap dispenser) whenever necessary

## **Monthly Cleaning:**

- Dust Heaters & light fixtures
- Wipe down stove and clean inside of oven (if necessary)
- Wipe/disinfect outside and inside of microwave (if necessary)

## **Yearly Cleaning:**

• Scrubbing of all interior walls

## Please note the following:

- Building size- Approximately 3900 square feet per building
- One building includes office space and children's daycare. The second building includes office space and dental area. Janitorial Services are required for all areas.

### 2. Apartment- 3 bedrooms

#### Will request the following cleaning after guest has departed:

- Sweep & mop all areas (including rooms and bathroom)
- Wash bed lines and remake the beds
- Sanitize bathroom (bathtub/shower, sink and toilet), dust washer and dryer in bathroom
- Removal of garbage from all areas/clean cans when necessary
- Disinfect all doorknobs, light switches & other high touch areas
- There could be other requests while guest if occupying apartment

## Monthly cleaning:

 Cleaning of windows, heaters & dusting of light fixtures, ensure under/behind couches and under beds are kept dust free.

#### **Yearly cleaning:**

Yearly cleaning of walls & ceilings
