

**REGULATIONS TO AMEND THE INUIT COMMUNITY CORPORATIONS CHAIRPERSONS
ELECTION FORMS REGULATIONS (2022)**

The First Minister of the Nunatsiavut Government is pleased to enact the following regulation:

Short Title

1.

These regulations may be cited as the *Inuit Community Corporations Chairpersons Election Forms (Amendment) Regulations, 2022*.

Authority

2.

These regulations are made under subsection 3(2) of the *Inuit Community Corporations Chairpersons Elections Act* (the "*Act*").

Interpretation

3.

Unless the context otherwise requires, terms used in these regulations have the same meaning as in the *Act*.

The *Inuit Community Corporations Chairpersons Election Forms Regulations*, is amended by adding the form set out in Schedule A as Form C-2.1 immediately after Form C-2.

The *Inuit Community Corporations Chairpersons Election Forms Regulations*, is amended by adding the form set out in Schedule B as Form C-3.1 immediately after Form C-3.

Amendment to add Form C-29.1

The *Inuit Community Corporations Chairpersons Election Forms Regulations*, is amended by adding the form set out in Schedule C as Form C-29.1 immediately after Form C-29.

Amendment to add Form 06

The *Inuit Community Corporations Chairpersons Election Forms Regulations*, is amended by adding the form set out in Schedule D as Form 06 immediately after Form 05.

Amendment to add Form C-34.1

The *Inuit Community Corporations Chairpersons Election Forms Regulations*, is amended by adding the form set out in Schedule E as Form C-34.1 immediately after Form C-34.

Amendment to add Form C-36

The *Inuit Community Corporations Chairpersons Election Forms Regulations*, is amended by adding the form set out in Schedule F as Form C-36 immediately after Form C-35.

Amendment to add Form A-4

The *Inuit Community Corporations Chairpersons Election Forms Regulations*, is amended by adding the form set out in Schedule K as Form A-4 immediately after Form A-3.

This Regulation is to be taken for all purposes to have come into effect on August 10, 2022.

DIRECTIONS FOR THE GUIDANCE OF VOTERS

How to Vote:

1. Take the ballot into the polling booth, and with the pencil provided, mark an "X" opposite the name of the candidate for whom you wish to vote.
2. After marking the ballot, you must fold it to conceal the name(s) of the candidate(s) for whom you have voted.
3. Either give the ballot to the elections officer at the poll to be placed in the correct ballot box or place it in the correct ballot box yourself.
4. You must then immediately leave the polling station.

If you spoil a ballot by mistake you may return it to the elections officer at the poll who will, if they are satisfied that the spoiling of the ballot was by mistake, give you another ballot.

Do not vote for more than one candidate; if you do so the ballot will be void and any votes cast for any candidate(s) on the ballot will not be counted.

Do not mark the ballot in any way that can identify you as the voter.

Do not tear, deface or mark on the ballot in any way that could identify you as the voter, if you do the ballot will be void and will not be counted.

Do not take a ballot out of the polling station.

Do not take photographs at the polling station.

Do not take photographs of your ballot.
