The Nunatsiavut Electoral Officer is pleased to enact the following regulations:

Short Title

1.

These regulations may be cited as the Nunatsiavut Election Forms Regulations.

Authority

2.

These regulations are made under subsection 5(10) of the Nunatsiavut Elections Act.

Interpretation

3.

Terms used in these regulations and in the prescribed forms have the meanings assigned to them in the *Nunatsiavut Elections Act*.

4.

The forms set out in Schedules A, B and C attached to these regulations are the forms prescribed for purposes of the *Nunatsiavut Elections Act*.

Forms in Schedule A may be used in Presidential Elections

5.

The Nunatsiavut Electoral Officer may, in his or her discretion, direct that forms set out in Schedule A shall be used at an election for President making all changes in points of detail as the Nunatsiavut Electoral Officer considers necessary or appropriate. (NGSL 2016 - 03)

Correction of Errors in Forms

6.

The Nunatsiavut Electoral Officer or an election official may, when using or printing a prescribed form set out in Schedule A, B or C, correct minor and typographical errors without first requiring a formal amendment to these regulations or the form. (NGSL 2016 - 03)
